

Releases, Terms and Conditions:

All reasonable attempts will be made to ensure your student's safety. In case of an emergency, I permit for my child to be treated as necessary. I understand this is an active, hands-on program. I acknowledge and understand that there is a risk of injury involved in participation and that the program, nor its trained professionals, can eliminate risk of injury. By signing this form I am indicating that I knowingly accept and assume the risk of injury that might occur from participation in this program. Parents and guardians agree not to hold Science of Fun, Kristen Thornton-Webb, N. Decatur Presbyterian Church, Academe of the Oaks, the transportation provider, or any of their employees, agents, or representatives, responsible for any accidents or injuries that occur. Photos and videos of students and activities may be publicly shared and used in promotional materials unless you notify the Director in writing, on or before the first day of attendance. I acknowledge that I have been informed that this program is not a licensed childcare facility. I also understand that this program is not required to be licensed by the Georgia Department of Early Care and that this program is exempt from state licensing requirements. The Science of Fun does carry liability insurance. Students whose behavior endangers others or is not conducive to the environment will be removed from the program without refund/credit/transfer/exchange. The aforementioned releases apply to all past/present/future enrollments. Science of Fun reserves the right to cancel, change, correct, modify, and update these policies at any time. The program must meet minimum enrollment or it will be canceled (extremely unlikely).

Informed Consent and Waiver of Liability Relating to Coronavirus/COVID-19:

Science of Fun Camp and North Decatur Presbyterian Church Decatur, Georgia. The Science of Fun and North Decatur Presbyterian Church Decatur have put in place preventative measures to reduce the spread of COVID-19; however, The Science of Fun and North Decatur Presbyterian Church Decatur cannot guarantee that I or my child(ren) will not become infected with COVID-19. By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending The Science of Fun camp and that such exposure or infection may result in personal injury, illness, permanent disability, and/or death. I understand that the risk of becoming exposed to or infected by COVID-19 at The Science of Fun camp may result from the actions, omissions, or negligence of myself and others, including, but not limited to, The Science of Fun camp and North Decatur Presbyterian Church employees, volunteers, and program participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself

(including, but not limited to, personal injury, disability, and/or death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at The Science of Fun camp or participation in The Science of Fun programming ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless The Science of Fun and North Decatur Presbyterian Church, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of The Science of Fun and North Decatur Presbyterian Church, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any The Science of Fun program.

General Use Waiver for North Decatur Presbyterian Church:

In consideration for gaining access to North Decatur Presbyterian Church for attending functions related to The Science of Fun, Inc., on behalf of myself, my spouse, my children, my heirs, assigns, personal representatives and estate, I hereby release, indemnify, hold harmless, and discharge Church/School, its members, agents, owners, officers, affiliates, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf, as follows:

1. I acknowledge that my or my child(ren)'s use of Church/School facilities or participation in and use of all Church/School facilities shall be undertaken at my own risk, and I expressly agree and promise to accept and assume all of the risks existing in this activity. My or my child(ren)'s participation in this activity is purely voluntary, and I elect to participate despite any risks.

2. I hereby voluntarily and expressly release, forever discharge, and agree to defend, indemnify, and hold harmless Church/School from any and all claims, demands, injuries, of any kind and nature, that are in any way connected with my and/or my child(ren)'s attending functions related to the The Science of Fun, Inc. at Church/School and/or my and/or my child(ren)'s use of Church/School's equipment or facilities including, but not limited to, any such claims based upon damages caused or alleged to have been caused in whole or in part by the negligent acts or omissions of Church/School. Church/School shall not be liable for any claims, demands, injuries, damages, actions or causes of action which arise wholly or partially due the negligence of Church/School arising out of or connected with the use of any of Church/School's services or facilities.

3. I agree that if any portion of this Agreement is found to be void or

unenforceable, the remaining portions shall remain in full force and effect.

I further certify that I am the parent or legal guardian of the child(ren) listed on this Agreement/Registration or that I have been granted power of attorney to sign this Agreement on behalf of the parent or legal guardian of the child(ren) listed above.

Summer Camp Refund and Cancellation Policies

December - February Early Registrations:

Camps purchased during our December - February Registration promotions are fully non-refundable. However, you may reschedule by April 30, 2024, less a \$25 per camper administrative fee, subject to availability. All camp changes will be priced at the current rates. One change per camper, no transfers.

Regular Registrations:

Cancellations and changes are due by April 30, 2024. \$100/session is non-refundable. \$25 per camper administrative fee for each change, changes are subject to availability. All camp changes will be priced at the current rates. One change per camper, no transfers. May 1 and after: No changes or cancellations. No exceptions.

As a small business, we are unable to issue cash/credit card refunds; refunds are always given in the form of SOF credit toward future purchases.

Break Camp Refund and Cancellation Policies

Special Registrations:

Camps purchased with promotional codes are fully non-refundable. However, you may reschedule at least 15 days before the first day of camp, less a \$25 per camper administrative fee, subject to availability. All camp changes will be priced at the current rates. One change per camper, no transfers.

Regular Registrations:

Cancellations must be made 30 days before the first day of break camp; \$100 per camper per week (\$10/day) is non-refundable.

Rescheduling requests are due 15 days before the first day of camp. Changes in camp sessions may be accommodated as space allows. \$25 per camper administrative fee for each change, subject to availability. One change per camper, no transfers.

As a small business, we are unable to issue cash/credit card refunds; refunds are always given in the form of SOF credit toward future purchases.

Behavioral Expectations:

Behavior is rarely a problem as we have experienced teachers, engaging activities, great campers, and fun counselors. Any camper who endangers themselves or others, has behavior that is not conducive to the camp environment, or has difficulty following rules will be removed immediately, without additional warnings, without refund/credit/exchange/transfer of any fees, and will not be allowed to return to the Science of Fun. Please note: Siblings who fight and/or argue will be removed from camp under these same guidelines.
